

Customer Service Advice from Telstra

Extreme Weather events impact service in Perth and WA South

Telstra is working to manage the significant impact to Telstra services that has occurred as a result of a series of extreme weather events in the Perth and WA south region of Western Australia on or about Saturday 31 May 2008.

Due to the effect of damage to the Telstra telecommunications network by a severe weather system which brought with it lightning, hail, flash flooding and damaging winds there has been a significant increase in the number of Telstra services being reported as faulty. As a result, there has been some disruption to service and delays to normal installation and repair activities.

Telstra apologises to any affected customers.

Information as to the nature of these severe weather events can be sourced from the Bureau of Meteorology (BOM). Damaging winds and flash flooding referred to in the BOM Severe Weather Warning issued for 31 May 2008 initially at 10:10 AM Saturday 31 May 2008; all of which were widely reported in the news media after the events.

Telstra has identified that the effect of these circumstances applies to approximately 7336 services. This number may increase as Telstra assesses the full affect of the extreme weather conditions. Based on current information, the resumption date of normal service operations is expected to be 16 June 2008. This date is indicative only; Telstra customers should anticipate that some further delays may occur. Telstra regrets any inconvenience caused to customers and thanks them for their patience while this work is being undertaken.

Telstra services encompassed in this exemption are; in the area bounded by and including, but is not limited to the area starting at the south eastern corner of Karroun Hill Nature Reserve south to Bonnie Rock, then south east to Koolyanobbing, south through Marvel Loch to Holt Rock, then south east to Ravensthorpe, east to the Oldfield River and follow the river south east to the coast. Follow the coast in a clockwise direction past Albany, Windy Harbour, Margaret River, Mandurah, Perth and Lancelin to the north western corner of Wanagarren Nature Reserve, then follow the boundary of the nature reserve east and south to the south east corner of the reserve, then east to Lake Hinds, north east to Beacon and north back to Karroun Hill Nature Reserve. All suburbs, towns and off shore islands and coastal areas serviced by Telstra within these boundaries are encompassed in this exemption.

As these circumstances were outside of Telstra's control, Telstra is claiming an extension to time frames applying under the *Telecommunications (Customer Service Guarantee) Standard 2000 (No.2)*. This means that Telstra is notifying customers that normal service time frames may not be met during the period of 04 June 2008 to 16 June 2008 inclusive (based on Telstra's estimated recovery schedule correct at the time of publication of this notice).
