Extreme Weather events impact service in Brisbane

Telstra is working to manage the significant impact to Telstra services that has occurred as a result of a series of extreme weather events in the Brisbane region of Queensland, on or about Saturday 6 February 2010, through to Monday 8 February 2010.

Due to the effect of damage to the Telstra telecommunications network by severe weather, there has been a significant increase in the number of Telstra services being reported as faulty. As a result, there has been some disruption to service and delays to normal installation and repair activities.

Telstra apologises to any affected customers.

Information as to the nature of these severe weather events can be sourced from the Bureau of Meteorology (BOM). Heavy rainfall and flash flooding referred to in the BOM Severe Weather Warning issued for 6 February 2010 initially at 11:15 pm on Saturday 6 February 2010; all of which were widely reported in the news media after the events.

Telstra has identified that the effect of these circumstances applies to approximately 10077 services. This number may increase as Telstra assesses the full affect of the extreme weather conditions. Based on current information, the resumption date of normal service operations is expected to be 17 February 2010. This date is indicative only; Telstra customers should anticipate that some further delays may occur. Telstra regrets any inconvenience caused to customers and thanks them for their patience while this work is being undertaken.

Telstra services encompassed in this exemption are; in the area bounded by and including, but is not limited to the area starting at Sandgate follow the coastline south past Southport to Currumbin Creek then south to the New South Wales border, then follow the border west past Springbrook and the Mt Lindesay Highway to the eastern boundary of Main Range National Park, then follow the boundary in a north-westerly direction to Mt Castle, then north-east past Coleyville to Mutdapilly. From Mutdapilly go north through Amberley to Borallon, then northeast to the Brisbane Forest National Park. Follow the western boundary of the national park north and then go west to Daguilar range, then north-east to Ocean View, then north through Wamuran to Woodford, then north-east through Glass House Mountains to Beerwah, then south-east to the Bribie Island National Park and finally south east back to Sandgate. All suburbs, towns, off shore islands and coastal areas serviced by Telstra within these boundaries are encompassed in this exemption.

As these circumstances were outside of Telstra's control, Telstra is claiming an extension to time frames applying under the *Telecommunications (Customer Service Guarantee) Standard 2000 (No.2)*. This means that Telstra is notifying customers that normal service time frames may not be met during the period of **9 February 2010 to 17 February 2010** inclusive (based on Telstra's estimated recovery schedule correct at the time of publication of this notice).
